## TERMS & CONDITIONS OF SUNWIZE POWER & BATTERY

Any litigation concerning any receivable hereunder may be brought in the name of the credit grantor or assignee at the Company's sole discretion. This agreement is governed by the laws of the State of Arizona and jurisdiction for any suit or related action shall, at the Company's sole discretion, take place in Maricopa County, Arizona. The undersigned agrees to pay all costs, including, but not limited to, attorneys or collection fees, lien fees as well as court costs incurred in collecting balances past due. Should a dispute arise, the undersigned acknowledges that taxable court costs and any attorney's fees a Judge may determine to be reasonable in any litigation shall bear interest at the rate of 1.5% per month from the date judgment is entered until paid as allowed by applicable law.

The undersigned understands, acknowledges, and accepts all terms and conditions as stated in this agreement and certify that the information given is herein true and correct.
